ONEYEAR LIMITED WARRANTY:

If you are not located in the USA and there is a repair center for your country, please use their service for the fastest response. What Does The Warranty Cover?: AcousticSheep LLC warrants that its products shall be free from defects in materials or workmanship, with the exceptions stated below.

What Is The Period Of Coverage?: This warranty runs for one year from the date of purchase. The term of any warranties implied by law shall expire when your limited warranty expires. Some states and/or Member States in the European Union do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.
